



## MLI FASTBRAND RESELLER TERMS AND CONDITIONS

### 1. Appointment as a Reseller

FASTBRAND hereby appoints the Reseller as a non-exclusive Authorized Promotional Items Reseller. Resellers have the right to sell FASTBRAND products to end users in the form and packaging supplied by FASTBRAND. Stub printing on most products will carry the Reseller's name, phone number and the product number.

### 2. Support From FASTBRAND

FASTBRAND will provide the Reseller with sales tools to make Promotional Items sales an easy, profitable addition to the Reseller's income. FASTBRAND Reseller Representatives are available Monday through Friday, 9:00 a.m. to 5:00 p.m. Eastern Standard Time (except holidays) at 1-800-741-6838. Reseller Representatives will gladly answer all questions concerning the FASTBRAND program, products, ordering and invoicing. For Custom Printing orders and inquiries, also call 1-800-741-6838 during the same business hours.

### 3. Placing Orders

Orders can be placed by internet, phone, fax or mail. First time orders with new artwork can only be accepted by internet or mail, as faxing can distort logo artwork. Custom logos and other customer artwork may be redesigned to meet printing specifications, for which there will be an additional charge. Imprint information will be printed in our standard format, as shown in the catalog, unless otherwise noted on the order. Please specify starting number when applicable.

### 4. Delivery

We will ship products within a standard delivery schedule. Orders with custom artwork and special printing instructions will take longer. Reseller will prepay the freight charges (regular surface shipping) and Reseller will be responsible for actual costs for shipping and handling. Reseller will be charged actual shipping charges for all sales materials. FASTBRAND requires a shipping point in the USA or its territories. Orders shipping to Hawaii, Alaska, Puerto Rico, Guam and the U.S. Virgin Islands will be shipped via Air Parcel Post or UPS.

### 5. Sales Terms

Orders are subject to credit approval. Prepayment is required and will speed the orders through our credit department. For Resellers having received credit approval, terms are 50 percent deposit and 50 percent upon delivery. If any account is past due, new orders will be held until payment is received for the outstanding balance. FASTBRAND reserves the right to change a Reseller's open account status if payment history warrants. Sales tax will be accessed on sales materials and items purchased for Reseller's own use in certain states.

### 6. Guarantee

FASTBRAND is a member of the Advertising Specialty Institute. In the event of an approved product replacement, FASTBRAND offers a hassle-free guarantee! FASTBRAND liability does not extend beyond product replacement.

### 7. Parallel Marketing

The Reseller understands that FASTBRAND, a division of MLI Integrated Graphic Solutions, sells business Promotional Items through direct mail, independently and through the Advertising Specialty Institute. Further, the Reseller realizes that such marketing activity may reach some of the Reseller's customers incidentally, and offer products that serve a similar function. However, customers of FASTBRAND Resellers are maintained on a separate computer database and are NOT commingled with other MLI Integrated Graphic Solutions databases.
